SLOTTED CAPS AND NON-SLOTTED HATS

V-Gard protective caps and hats consist of a polyethylene shell and suspension system working together as a protection system. The rigid shell is lightweight and balanced for all-day wearing comfort. The shell is one-piece injection molded of high-density polyethylene and has a high dielectric strength.

V-Gard caps and hats meet or exceed the applicable requirements for a Type I helmet (top impact) as outlined in ANSI Z89.1, Class E. They are also certified to CSA Z94.1-2005 (Class E) with 1-Touch and Fas-Trac suspensions.

Sizes: Small (6" to 7-1/8"), Standard (6-1/2" to 8"), and Large (7-1/2" to 8-1/2").

Features a uni-ridge design. An injection-molded, impact-resistant polycarbonate shell is combined with a suspension system to provide a comfortable fit and effective protection from impact energy.

Topgard caps and hats meet or exceed the applicable requirements for a Type I helmet (top impact) as outlined in ANSI Z89.1 and CSA Z94.1-2005, Class E (electrical – high voltage).
