AZOV International is part of Zener Marine International Group a specialized marine & offshore division within a Spanish business holding operating across multiple strategic sectors.

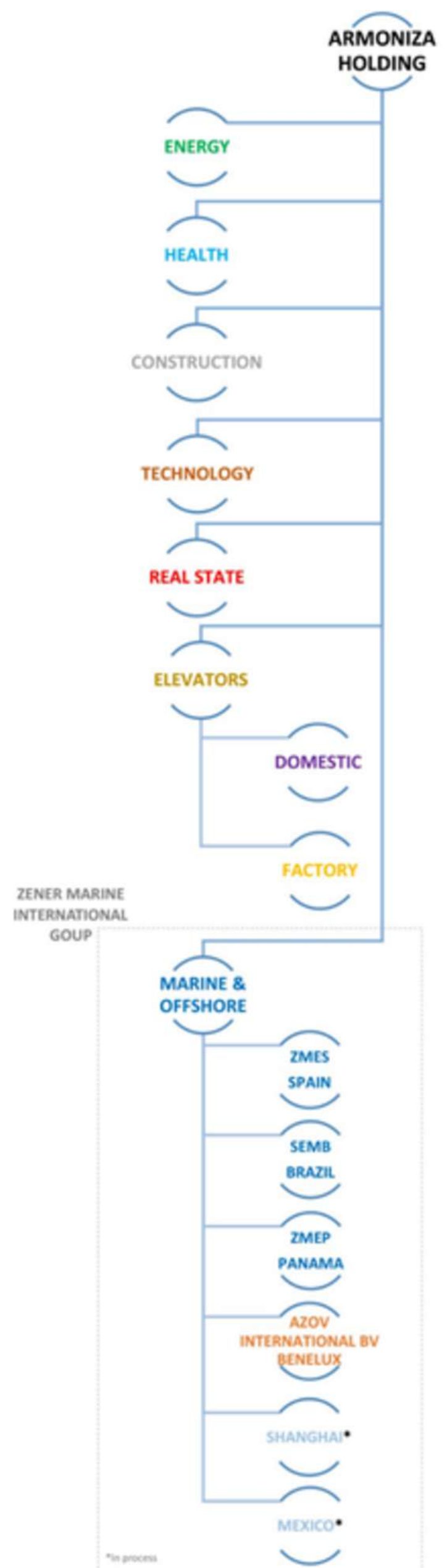
This group structure provides AZOV with financial stability, technical depth and long-term continuity, while preserving its independence and neutral role as a manufacturer representative.
